RULES & GUIDELINES

THE RACE COMMITTEE RESERVES THE RIGHT TO REJECT THE ENTRY OF, OR DISQUALIFY, ANY TEAM OR PERSON FAILING TO ABIDE BY THE FOLLOWING RULES

- Enter an experienced crew and steers-person
- Enter a canoe that meets ECORA specifications [400 lbs. or >]
- Abide directives of ECORA Race Officials
- Adhere to the race course
- Abide directives of the Coast Guard
- Carry a horn or whistle capable of a 2-second blast, audible _ mile onboard
- Stow 6 adult CG approved life-vests on board; wear them if conditions warrant

NAVIGATIONAL LAW

- Yield to all commercial traffic, never cutting in front of commercial vessels
- When in doubt pass to the stern (rear) of a vessel crossing in front of you
- One short blast means, "I intend to leave you on my port side (left-hand side)." Generally this means an alteration of course to your starboard (right-hand side).
- Two short blasts mean, "I intend to leave you on my starboard (right) side." In this case an alteration of course to port (the left) occurs.
- Three short blasts mean, "I am operating astern propulsion," which means that you are backing down.
- Five or more short blasts mean "danger" and are used when a vessel doubts whether sufficient action is being taken by the other vessel to avoid collision. Stay clear of vessels sounding danger signal
